**A RESOLUTION OF THE CITY OF KYLE, TEXAS, AUTHORIZING  
THE MAYOR TO EXECUTE AN INTERLOCAL PARTICIPATION  
AGREEMENT WITH THE INTERLOCAL PURCHASING SYSTEM  
(TIPS) PROGRAM; MAKING FINDINGS OF FACT; AND PROVIDING  
FOR RELATED MATTERS.**

**Whereas**, the City Council of the City of Kyle, Kyle, Texas, pursuant to the authority granted by Sections 271.081-271.083 Local Government Code, V.T.C.A., as amended, desires to participate in described purchasing programs of the Region VIII Education Service Center; and,

**Whereas**, in the opinion that participation in these programs will be highly beneficial to the taxpayers through the anticipated savings to be realized; and,

**Whereas**, The City Manager has properly reviewed the circumstances and is now recommending the Interlocal Agreement be authorized.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KYLE, HAYS COUNTY, TEXAS, THAT:**

**Section 1. Findings.** The following recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes as findings of fact.

**Section 2. Agreement.** The City of Kyle does request that the Cooperative include its stated needs for all categories, including but not limited to, instructional, maintenance, custodial and food service goods and services, on the Cooperative's Purchasing Program and award contracts for those items, whereby the Cooperative Members may be allowed to purchase those items from the Cooperative's contracts; and that Cooperative is authorized to sign and deliver all necessary requests and other documents in connection therewith for and on behalf of the Cooperative Members that have elected to participate. Executed copies of the Interlocal Agreement and Resolution from the Region VIII Education Center shall be attached to this resolution as exhibits.

**Section 3. Authorization.** The Mayor is hereby authorized to execute the Interlocal Agreement with Region VIII Education Service Center. Region VIII Education Service Center and The Interlocal Purchasing System (TIPS) Program have entered into an Agreement to provide cooperative purchasing opportunities to public agencies. This Agreement was approved by the governing boards of the respective parties at meetings that were posted and held in accordance with the Texas Open Meetings Act, Texas Government Code Ch. 551.

**Section 4. Effective Date.** This Resolution shall take effect from and after the date of its passage as authorized by the Charter of the City of Kyle.

**Section 5. Open Meetings.** That it is hereby officially found and determined that the meeting at which this Resolution is passed was open to the public as required and that public notice of the

time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551, Local Government Code.
