Primary Activity	Construction of Wastewater Collection System Improvements – Interceptor Sewer from Southlake Sewer Lift Station to Bunton Creek Sewer Lift Station.					
Background	City of Kyle, Texas is working with a company that wishes to locate a plant facility in Kyle and will be a relatively large user of water and sewer service. The anticipated sewer flows are estimated at 115,000 GPD to 140,000 GPD. There are some wastewater collection capacity issues caused by a bottleneck in the existing collection system that must be addressed through additional public infrastructure (sanitary sewer construction). To avoid overloading the existing Southlake Sewer Lift Station the construction of new interceptor sewer main is proposed. The proposed interceptor sewer will be installed so as to bypass the Southlake Lift Station and transport wastewater via gravity sewer to the Bunton Creek Sewer Lift Station. An 8"-dia. gravity sewer is considered the "minimum necessary" improvements to meet the needs of the business.					
	 The City will likely upsize the interceptor sewer to a larger dia. so that it is capable of accepting additional residential flows from development planned within the service area of the proposed interceptor. Under the Texas Capital Fund Program, the City will be required to receive bids for the 8-in dia. pipeline (base bid). Elective upsizing to handle future growth is acceptable if the larger size is bid as an additive alternate. The City would be responsible for the cost difference between the minimum necessary 8" pipeline and the larger sized line it elects to construct. 					

Commitments Necessary from CONFIDENTIAL

Job Creation CONFIDENTIAL must commit to create at least 66 additional full-time equivalent (FTE) jobs, fulfillment of which must be accomplished within 36 months of TCF grant award. A job is defined as a permanent full-time position held by one employee or two part-time employees a. A full-time job is defined as permanent employment for 35 hours or more per week per person. b. A part-time job is defined as permanent employment for 20 hours or more per week per person. Employees working less than 20 hours per week may not be counted individually or in combination/aggregate towards meeting the job goal of the business.

- **c.** Seasonal jobs are not eligible for consideration in the program. The position must be required year-round.
- **d.** Contract jobs are not eligible for consideration. Only permanent employees may be counted toward job creation requirements.
- **e.** Leased employees must meet the same requirements as described above, as long as the business has control over the leased employee(s).
- **f.** LMI classification of created jobs is determined based on the employees' household income at the date of hire, not on the pay rate of the job being created.
- g. Unfilled or vacant jobs/positions are not eligible for consideration.
- h. Any request to train new employees at an alternate location prior to beginning work at the project site location, as identified in the application and contract, must have prior written approval from TDA. Generally, requests for off-site training exceeding 60 days are not approved.
- i. Jobs created prior to the date of occupancy for the project will not be counted toward job creation requirements. In no case will jobs created prior to the award (or pre-agreement date, if applicable) be counted toward job creation requirements.
- **j.** Credit will only be given for jobs created/retained at the project site described in the application.
- **k.** No credit will be given for jobs transferred from other locations of the same business.
- No credit will be given for jobs held by principals of the business(es), or a spouse or dependent of the principal. Principals are defined as an individual or other legal entity that owns 20 percent or more of the business.

Low-Moderate Income CONFIDENTIAL must commit to ensure that, during the maximum 36month Texas Capital Fund Grant Contract Performance Period, at least 51% of the 66 additional jobs are filled by persons who, prior to their hiring, are persons of low and moderate income (LMI), as defined by the following income limits:

Private Investment	CONFIDENTIAL must commit to make and document a capital investment of at least \$9,775,000 in its planned facilities. Capital Investment made after grant award will be countable, and there is a mechanism for counting certain expenditures prior to grant award with State Agency Pre-Award Cost Approval. The most typical evidence of sufficiency is a Verification of Deposit Form.								
Environmental Clearance	CONFIDENTIAL must commit not to proceed with any of its privately funded capital investment or project site activities, including real property acquisition (if applicable) until the Funding Agency has issued environmental clearance required under 24 CFR Part 58. Note: It is possible to pursue environmental clearance, as well as submission and processing of the grant application simultaneously.
