David Douglas was called to speak on behalf of the Hometown Kyle HOA. He thanked the Council for adopting the impervious coverage ordinance. He requested Council to put the onus of requiring a permit on the HOAs. He also spoke on the Stormwater drainage utility fee. He stated that Hometown Kyle residents will be paying \$4,000.00 per month to the city, while still maintaining their own detention ponds. He stated their HOA currently has \$8,000.00 of planned improvements to their drainage, and that Waterleaf enjoys city maintenance of their detention ponds. He asked the city to consider paying for Hometown HOA's maintenance.

Cindy Slovak-Barton was called to speak. She spoke about the traffic and barricades on parking for an event that took place this past weekend. She stated that they blocked off the parking on Thursday morning for an event taking place Saturday morning, and she witnessed a couple having trouble because they had to park further away and walk to their destination.

Sarah Watson was called to speak. She announced the Hogwash event taking place this Friday and Saturday at Gregg-Clarke Park.

With no one else wishing to speak, and no objections to closing citizen comments, Mayor Webster closed citizen comments at 7:10 p.m.

Council Member Arabie stated that he is fundamentally opposed to the area becoming a warehouse district especially at the center of our city. Council Member Fogley offered support for the project, especially as it would relate to incubator space for small businesses to start out. Elliot Kilmer was called to speak on behalf of the Jordans. He stated they would like to put in a large warehouse in the front to start, with retail space. Council Member Arabie asked Mr. Koontz to clarify the two uses that are being asked for. Mr. Koontz stated that storage and warehouse components as primary uses for the property. Mrs. Jordan stated that the flag poles are
