Mayor Webster brought forward Item No. 18 for discussion. Ms. Roecker presented the item. She addressed the questions presented during citizen comments, stating that the reason it is a fee rather than a tax is because it is not based on the property value of a property, but rather its impact on the drainage system. Mayor Webster stated that this fee is a dedicated fee and can only be used for the established purposes. Ms. Roecker confirmed his statement is correct as per state statute. She continued that she is unaware of any positions posted, but she was hired in December 2015 as the Stormwater Management Plan Administrator, however that was to administer the municipal separate sewer system permit, which is an environmental program federally unfunded mandate. She stated that they did carefully consider the \$5.00 fee, however the fee is necessary to meet the tasks. Ms. Roecker recalled her previous presentation to Council which included a chart of Texas cities' drainage utility fees showing that \$5.00 is below average. Council Member Wilson stated that he would like it on the record about a calculation he and Ms. Roecker estimated for a property with active AG use with a small house and a considerable barn on 400 acres. Ms. Roecker stated that it would fall under the residential rate. She stated that if it was an undeveloped (no home on it) cattle property AG use, it would be exempt per state statute, and if it was a business it would fall under commercial. Council discussion continued.

Mayor Webster opened the public hearing at 8:04 p.m. With no one wishing to speak, and no objections to closing the public hearing, Mayor Webster closed the public hearing at 8:05 p.m.

The text amendment process begins on November 22, 2016, and will come to Council on December 6, 2016. Mayor Webster brought forward Item No. 25 for discussion. He spoke about a letter he received from HUD a few weeks ago. He stated that the relationship to the city is that the Mayor unilaterally appoints members of the Housing Authority Board. He stated that board members are to serve two-year terms, but no appointments have been made since 2007. Mayor Webster stated that during an audit there were some concerns brought forward regarding the oversight and management of the Authority. The City is not responsible for the oversight of the Authority. He brought it before Council in order to find out if there is support for city staff financial advice, potential attorney time, and other support to the bridge the board over the transition period. He will be appointing a special task board to establish procedures and set up the organization, at which point they may determine whether to remain on the board or be replaced. The appointees will be Michelle Lopez, former City Council member; Daniel Harper, Vice Chancellor of Finance for Texas State University and former Director of the Senate Finance Committee; Lisa Adams who has run the hospice centers in Hays County and has much experience dealing with board structures; Veronica Sanders, a criminal defense attorney; and Claire Rodriguez, a long time resident and has a lot of experience from a mission standpoint from St. Anthony's. He also must appoint two members from the housing authorities themselves.

It was a consensus of Council to assist the Housing Authority with administrative assistance for a short period of time to get the organization moving in a positive direction.
