AN ORDINANCE AMENDING CHAPTER 53 (ZONING) OF THE CITY OF KYLE, TEXAS, FOR THE PURPOSE OF ASSIGNING ORIGINAL ZONING TO APPROXIMATELY 4.01 ACRES OF LAND FROM AGRICULTURE 'AG' TO RETAIL SERVICE DISTRICT 'RS' FOR PROPERTY LOCATED AT 1381 GOFORTH ROAD, IN HAYS COUNTY, TEXAS. (JOHN R. AND GAYLA SIMON -Z-16-013); AUTHORIZING THE CITY SECRETARY TO AMEND THE ZONING MAP OF THE CITY OF KYLE SO AS TO REFLECT THIS CHANGE; PROVIDING FOR **PUBLICATION** AND **EFFECTIVE** DATE; **PROVIDING** SEVERABILITY; AND ORDAINING OTHER PROVISIONS RELATED TO THE SUBJECT MATTER HEREOF: FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE WAS PASSED WAS OPEN TO THE PUBLIC AS REQUIRED BY LAW.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KYLE, TEXAS, THAT:

SECTION 1. That the zoning district map of the City of Kyle adopted in Chapter 53 (Zoning) be and the same is hereby amended to assign original zoning to approximately 4.01 acres of land from Agriculture 'AG' to Retail Service District 'RS' for property located at 1381 Goforth Road, as shown on the property location map labeled Exhibit B.

<u>SECTION 2</u>. That the City Secretary is hereby authorized and directed to designate the tract of land zoned herein as such on the zoning district map of the City of Kyle and by proper endorsement indicate the authority for said notation.

SECTION 3. If any provision, section, sentence, clause, or phrase of this Ordinance, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void or invalid (or for any reason unenforceable), the validity of the remaining portions of this Ordinance or the application to such other persons or sets of circumstances shall not be affected hereby, it being the intent of the City Council of the City of Kyle in adopting this Ordinance, that no portion hereof or provision contained herein shall become inoperative or fail by reason of any unconstitutionality or invalidity of any other portion or provision.

<u>SECTION 4</u>. This Ordinance shall be published according to law and shall be and remain in full force and effect from and after the date of publication.

<u>SECTION 5</u>. It is hereby officially found and determined that the meeting at which this ordinance was passed was open to the public as required by law.

FIELD NOTE DESCRIPTION OF A SURVEY OF 1.22 ACRES OF LAND OUT OF THE JOHN STEWART LEAGUE HAYS COUNTY, TEXAS

Baverda by Delvin Simon by deed dated March 10, 1972 and recorded in Volume 249, Page 55, Hays County Deed Records, for the south corner of

the tract herein described; THENCE, leaving the raid Haverda 3.00 acre tract, with fence, H 45 49' 80" E, 244-24 feet to a corner fence post for the east corner of the tract herein described;

THENCE, with fence, N 43 44' 49" H, at 196.30 feet passing the east corner of a proposed 20 foot road easement and continuing on, in all, 216.30 feet to a 60d spike with washer set in a 6 wood fence post for the north corner of the tract herein described, same being the north corner of the said proposed 20 foot road easement, and in the southeast line of that tract of land conveyed to Charles Schlemmer by Aline B. Schlemmer by deed dated June 27, 1972 and recorded in Volume 25, Page 272, Hays County Deed Records;
