Ms. Huey spoke about the proximity to the pool and stated that it is a long stretch of road with no stop signs. She would like a warning sign in hopes of preventing an accident. Mayor Webster spoke about the traffic policy. He stated that Chief Barnett would contact Ms. Huey to get that process started. Ms. Huey also spoke about sidewalks, stating that Plum Creek put in trees near the sidewalks that are pushing the sidewalks up and she stated that many developers put in cheap sidewalks. She stated that residents are upset that the liability is resting on the homeowners. Mayor Webster stated that the City has a law in the books from 1964 assigning this responsibility to the homeowners. He stated that the City is in the research phase at this point and is looking to provide a more affordable option.

Arturo Guerra of Guerra Underground was called to speak. He stated that it was a great experience working in Kyle, and he hopes to work past these items. Mayor Pro Tem Fogley asked him to speak about the delay in the completion of the project. He stated that there was no geo-tech report provided with the packet, and the rock was much hard than anticipated. The result was that it took a long time to work through. He stated that they have a plat and they use Google maps, which there was some tree coverage that prohibited vision of the homes in the area. He stated that they had to remove a deck and reinstall it, and in other areas, homeowners had used the line as storage area for 20 years and they had to relocate items. Mr. Guerra said originally, there was a 50-foot segment with restricted hours, but during the project, it ended up being about 740 feet of restricted hours due to school traffic.
