Mayor Webster brought forward Item No. 5 for discussion. Council Member Wilson arrived at 8:37 a.m.

Mr. Sellers presented the Kyle Core Values and discussed results from the 2017 City of Kyle Household Survey Results. Mr. Sellers spoke about population history and projections, building permit statistics, and utility customer account statistics. He presented a Planned Residential Growth Areas map. He spoke about wastewater challenges related to the growth and status of the Wastewater Treatment Plant expansion project. Mr. Sellers presented the revenue estimates for 2018. He continued with presenting department budgets. Mr. Sellers presented the Budget Priorities for 2018 and covered debt issuances. He closed with next steps in the budget schedule.

Mayor Webster opened up discussion for Council feedback. Mayor Pro Tem Fogley expressed support for the Police Department body-worn cameras. Council Member Tenorio asked the Chief about the training and the new bulletproof vests. Council Member Mitchell discussed keeping the budget and projects all within reducing the tax rate. Mayor Webster spoke about personnel funding at a percentage that reflects the on boarding phase and the vacancy savings issues. Council Member Tenorio stated that she would not support any increases. She stated that fees on the utility bill need to be considered in relation to the tax revenues. She would like to see a 5% reduction across all budgets. Council Member Tenorio stated the City needs to scale back its wants. Council Member Wilson stated that he remains focused on lowering the burden on the homeowners of Kyle. He would like to use federal funding to get the planning phases completed to work towards being shovel-ready for businesses. Council Member Wilson stated that citizens look toward the city to relieve their tax burden although the city's portion is just a fraction of the total property tax bill. He stated that citizens are not going to the other entities, but rather their city representatives. Mayor Pro Tem Fogley expressed interest in a reduction as well. He stated that CIP and WW projects are going to require tough decisions. Council Member Arabie stated that the budget cuts from the city would affect the citizens' quality of life the most. Council Member Selbera asked how it would look if the entire budget was allocated towards the necessary infrastructure needs. Council Member Tenorio asked whether there is a dedicated staff member seeking grants. Mr. Sellers stated that while there is no dedicated grant writer, staff is always seeking outside funds, many written in house. He mentioned that the police department has obtained several grants and the Alsco grant was awarded using a third party administrator. Council Member Mitchell stated that he has been financially conservative since he began running for council. He stated that with that said, it is important to delay gratification, and yet the staff does great things with the funds they have.

## V. ADJOURN

Mayor Pro Tem Fogley moved to adjourn. Council Member Mitchell seconded the motion. All votes aye; motion carried 7-0.

With no further business to discuss, the City Council adjourned at 11:09 a.m.
