# Supplemental Work Authorization # 4: Goforth Road Widening, Reconstruction, and Extension

## Additional Services to be provided by the LAN Team

### **Function Code 351 – Construction Engineering**

ENGINEER will continue to support the construction phase of the project as follows.

- 1. Construction Engineering
  - 1.1 The ENGINEER shall review and comment on Contractor generated submittals and shop drawings for conformance to the project specifications. Review will be limited to up to 40 submittals at two (2) hours per submittal and includes one re-review of each, as needed.
  - 1.2 The ENGINEER shall review and respond to up to 12 Contractor generated requests for information (RFIs).
  - 1.3 The ENGINEER will continue to be available for additional phone meetings and discussions through the estimated construction completion at the end of May, 2017.
  - 1.4 The ENGINEER will investigate different options to run the Kyle Parkway signal off of different services including the proposed illumination service. Voltage drops and calculations will be run and applicable tables updated to allow the contractor to construct the work.
  - 1.5 The ENGINEER will assist the City of Kyle with development of Exhibits needed by the County Line Attorney.
  - 1.6 The ENGINEER will no longer need to develop As-Built Plans so this work is being removed from the ENGINEER's scope of work and required deliverables.

- Response to Contractor's Submittals and Shop Drawings
- Response to Contractor's Request for Information
- Traffic Signal/Illumination Loading Tables
- Exhibits for the County Line Attorney as required by the City of Kyle

#### SERVICES EXCLUDED FROM THE BASIC SCOPE OF SERVICES
