

**SUPPLEMENTAL WORK AUTHORIZATION NO. 4**  
**Goforth Road Project**

---

WHEREAS, on the 28th day of March, 2014, a professional services agreement was entered into by and between the City of Kyle("City") and Lockwood, Andrews & Newnam, Inc. ("Consultant"), collectively known as the "parties," for the development of a preliminary engineering report, limited environmental studies, schematic, plans, specifications, and estimate (PS&E), utility coordination and design, traffic studies, geotechnical analysis, and pavement design to develop Goforth Road from the IH 35 E. Frontage Road to Bunton Creek Road Intersection, in Hays County, Texas; and,

WHEREAS, during the development of the project, it was determined additional construction engineering services were needed to validate the use of the proposed road materials, review and provide guidance on additional requests made by the Contractor due to unknown utility conflicts arising, perform an electrical loading analysis due to minimization of meter services, determine a way to power the proposed signal at Bunton and Goforth, provide plan sheets needed for inclusion in an agreement between the City and County Line Special Utility District, and provide plan sheets that reflected changes made to the project and these items were requested by the City and the Consultant requested additional compensation in the amount of \$42,175.00; and,

WHEREAS, the additional construction engineering services to be performed by the Consultant ("supplemental work") are described and set forth in EXHIBIT "A" which is attached hereto and incorporated by reference herein; and,

WHEREAS, after careful review of the support documentation, the City has agreed to an amount not to exceed, \$42,175.00 for the purpose of compensating the Consultant to perform the supplemental work described in EXHIBIT "A";and,

WHEREAS, at its regular meeting on June 6, 2017, the city council approved an amount not to exceed \$42,175.00 for the purpose of compensating the Consultant to perform the supplemental work described in EXHIBIT "A";

NOW THEREFORE, IT IS HEREBY AGREED between the parties hereto that Supplemental Work Authorization #4 ("Authorization") in an amount not to exceed \$42,175.00 is fair and reasonable, and this Authorization will become effective immediately upon the signature of both parties.
