The funding for this amendment to the professional services agreement with LOCKWOOD, ANDREWS & NEWNAM, INC., for additional engineering services will be provided from the General Obligation Bonds, Series 2013 and 2015 issued for engineering, design, and related services for the five (5) roadway improvement projects.

### ADDITIONAL INFORMATION/COUNCIL ACTION:

- If approved by City Council, Supplement No. 4 in the amount of \$42,175.00 to LOCKWOOD, ANDREWS & NEWNAM, INC., will increase the total engineering services contract award to \$1,426,435.51 for the Goforth Road improvement project.
- On July 7, 2015, City Council approved supplement number 3 in the amount of \$75,198.00 to the agreement with LOCKWOOD, ANDREWS & NEWNAM, INC., for the Goforth Road improvement project.

- On November 5, 2014, City Council approved supplement number 2 in the amount of \$204,930.25 to the agreement with LOCKWOOD, ANDREWS & NEWNAM, INC., for the purpose of providing engineering services and documents necessary for the development of project plans, estimates, specifications for bidding of Goforth Extension new location roadway improvements.
- On October 8, 2014, City Council approved supplement number 1 to increase funding for LOCKWOOD, ANDREWS & NEWNAM, INC., by \$102,863.00 for the purpose of providing Right of Way services and documents, (parcel plats, appraisal reports, etc.); and an archeological survey necessary for the acquisition of properties for the Goforth proposed roadway improvements.
- On March 18, 2014, City Council approved a professional services agreement for engineering services with LOCKWOOD, ANDREWS & NEWNAM, INC., in an amount not to exceed \$1,001,269.26 for engineering services for the Goforth Road project.
