Submission of Bid

Bids shall be submitted upon the blank forms provided in a sealed envelope plainly marked in the left hand corner, BID FOR "PW – OSR H20 2017" Old Stagecoach Road Water Line Project Trenching".

Deadline

All bids must be submitted prior to 3:00 P. M. on Monday, June 12, 2017. Any bids received after closing time will be returned unopened. Bids must be mailed or delivered to the City of Kyle at 520 E RM 150, Kyle, TX 78640.

Name of Bidder

Bidding party must give full firm name and address. Failure to manually sign the bid will disqualify it. Person signing the bid should show TITLE and AUTHORITY TO BIND HIS FIRM IN A CONTRACT.

Contract

This bid, when properly accepted by the City of Kyle, shall constitute a contract equally binding between the successful bidder and the City of Kyle, Texas. City may delay acceptance of bids for 60 days from date of opening.

Prices

Bid prices must be firm for three months after bid opening date. The City is exempt from taxes, do not include tax on bid. Unit price should reflect all charges, including shipping charges. Bids subject to unlimited price increases will not be considered.

Delivery

Bid price must include all mobilization charges.

Alterations by Bidder
