I. Call Meeting To Order

Mayor Webster called the meeting to order at 4:01 p.m.

Mayor Webster asked the secretary to call roll. Present were: Mayor Webster, Council Member Mitchell, and Council Member Tenorio. A quorum was present. Mayor Webster mentioned that for the purpose of canvassing an election, two members of council constitute a quorum.

II. Citizen Comment Period with City Council

Mayor Webster opened citizen comments at 4:02 p.m. With no one wishing to speak, and no objections to closing citizen comments, Mayor Webster closed citizen comments at 4:02 p.m.

III. Consider and Possible Action

1. A Resolution Canvassing the Returns and Declaring the Results of the November 7, 2017, General and Special Elections of the City of Kyle, Texas. ~ *R. Todd Webster, Mayor*

Mayor Webster brought forward Item No. 1 for discussion. Mayor Webster read the results of the November 7, 2017.

For Mayor: Bill Sinor 153 early votes and 132 Election Day votes for 285 total votes. Jaime Sanchez had 102 early votes and 97 Election Day votes for 199 total votes. Nicole Romero-Piche 76 early votes and 103 Election Day votes for 179 total votes. Travis Mitchell had 528 early votes and 436 Election Day votes for 964 total votes.

For District 2: Tracy Scheel had 0 early votes and 80 Election Day votes for 80 total votes.

For District 4: Alex Villalobos had 214 early votes and 250 Election Day votes for 449 total votes. Tim McHutchion had 203 early votes and 129 Election Day votes for 332 total votes.

It is found, determined and declared by the City Council that said election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law; and that Travis Mitchell was duly elected as Mayor, and that Tracy Scheel was duly elected to Council District 2; and that Alex Villalobos was duly elected to Council

District 4. Said above named parties are hereby declared duly elected to said offices, subject to the taking of the oath of office as provided by the laws of the State of Texas.

For District 1: Marco Pizana had 364 early votes and 341 Election Day votes for 705 total votes. Dex Ellison had 439 early votes and 380 Election Day votes for 819 total votes.

It is found, determined and declared by the City Council that said election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law; and that Dex Ellison was duly elected to Council District 1. Said above named party is hereby declared duly elected to said office, subject to the taking of the oath of office as provided by the laws of the State of Texas.

Council Member Tenorio moved to approve a Resolution Canvassing the Returns and Declaring the Results of the November 7, 2017, General and Special Elections of the City of Kyle, Texas. Mayor Webster seconded the motion. All votes aye; motion carried 3-0.
