**A RESOLUTION OF THE CITY OF KYLE RENAMING THE HISTORIC
KYLE CITY HALL TO KRUG ACTIVITY CENTER**

WHEREAS, the City of Kyle, Texas, a Texas home rule municipality (herein the "City"), owns the Historic Kyle City Hall located at 101 S. Burleson Street; and

WHEREAS, the Historic Kyle City Hall has been an important landmark and cultural center for the City of Kyle since 1912, and

WHEREAS, the Historic Kyle City Hall has not functioned as a City Hall since 2007, but has since served as an activity center for the citizenry of Kyle; and

WHEREAS, John P. "Pete" Krug entered into a career in public service in law enforcement working at the Hays County Sheriff's Department, the Austin Airport Police Department, and the Kyle Police Department; and

WHEREAS, Pete Krug served the City of Kyle in many capacities over several years, including as Mayor, and numerous commissions/committees including Home Rule Charter Commission, Home Rule Charter Review Committee, Ethics Committee, Civil Service Commission, Kyle Fair on the Square Committee, and City Hiring Committees, as well as other local organizations including the Kyle Volunteer Fire Department, and Training Board for the Hays County Sheriff's Office; and

WHEREAS, Pete Krug was an active member of other civic organizations including Disabled American Veterans, Kyle/Buda Veterans of Foreign Wars Post #12085 and AMVETS Post #115, and the Live Oak (Kyle) #304 Masonic Lodge, the Buda #800 Masonic Lodge and the Rambo #426 Masonic Lodge; and

WHEREAS, Pete Krug's residence was across the street from the Historic Kyle City Hall for several decades and took personal care to watch over and protect the building; and

WHEREAS, Pete Krug passed away in 2017 and the Mayor & Council seek to honor the life and service of Pete Krug to the Kyle Community;

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF KYLE, TEXAS, THAT:**

Section 1. Findings. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes as findings of fact.

Section 2. Name Change. The Historic Kyle City Hall located at 101 S. Burleson Street, Kyle, Texas 78640 shall henceforth be named the Krug Activity Center.

Section 3. That it is hereby officially found and determined that the meeting at which this resolution is passed is open to the public and that public notice of the time, place, and purpose of said meeting was given as required by law.
