NOTICE TO RESPONDERS:

The City of Kyle is accepting proposals for trail improvements at the Plum Creek Trail as stated in this RFQ and posted on our website: www.cityofkyle.com. The City of Kyle invites qualified companies to submit proposals to provide trail improvements cost estimates for the Plum Creek Trail. The city is seeking a company with trail improvement experience as well as experience working with public municipal agencies. REQUEST FOR QUALIFICATIONS DEADLINE: 5:00 PM, WEDNESDAY, OCTOBER 11, 2023

All proposals received will be reviewed by the Trails Committee and City Staff. The staff's recommendation will go to the Kyle City Council for final approval.

Proposals should be clearly marked, "**PLUM CREEK TRAIL IMPROVEMENTS-RFQ-2023-36-PARD**". Any proposal received later than the specified time, whether delivered in person, postal mail or emailed shall be disqualified. The City of Kyle will not be responsible for delivering mail from the post office. The City of Kyle will not be responsible for proposals delivered to any location other than the one specified above. The City of Kyle will not be responsible for emailed proposals that did not get into "in-box". Respondents are encouraged to hand deliver their proposals well ahead of opening time or follow up to confirm their proposals were received before deadline.

The City of Kyle reserves the right to reject any or all proposals submitted. Resolution 795-Adopted March 20, 2012: The City of Kyle City Council hereby gives local preferences if the contractor meets requirements under the Local Government Code Section 271.9051.

The City of Kyle is exempt from taxation under the Sales Tax and Use Tax Laws, and proposals shall not include such taxes.

SCOPES:

1. A site visit is optional prior to any company submitting a proposal. The site visit must be accompanied by a City of Kyle representative. Site visits may be scheduled during normal business hours between September 20, 2023, and October 11, 2023. To schedule a visit, please contact City of Kyle Parks and Recreation Director as listed above.
2. The Request for Proposal is to include cost estimates to include, but not limited to the following:
PLUM CREEK TRAIL IMPROVEMENTS-RFQ-2023-36-PARD

- Three shaded rest stops
 - One outdoor green or electric restroom at the intersection of Bunton Creek and Plum Creek Trail.
 - Five interactive kiosks with a QR Code along the Plum Creek Trail, including two at the trail head signs.
 - One trail dozer
 - One skid steer to be compatible with a caterpillar forestry mulcher attachment (100 M).
 - A parking lot between Twin Cove and Treeta Trail off Lynn Dr and Creekside.
 - Fifteen interpretive signs that include trail history, plant life/trees along the trail, endangered species along the trail, and water direction map.
 - Outdoor exercise equipment at the Waterleaf Trailhead area and the Bunton Park Trailhead area.
 - Three call centers that include solar powered charging stations, a bike repair station, emergency locator signs, and a water fountain.
3. It is customary and common for City Departments to request proposals for participation in programs funded or sponsored by the City. City parks are fully funded by City tax dollars. Therefore, the agreement to provide these services must be open to all interested in submitting a proposal. By submitting an RFQ, the organization agrees to the terms and proposals being submitted.
 4. The Kyle Parks and Recreation Department reserves the right to accept or reject any proposal submitted for any and all reasons.
 5. The contractor should take all precautions necessary to protect the safety of park and trail users around the area of installation and construction.
 6. Trail improvements must meet the safety, design, and construction standards for trail improvement projects.
 7. Trail improvements must be installed in full compliance with all applicable local, state, and federal regulations during the construction phase.
 8. Winning proposals shall work with the City to obtain access agreements and applicable liability insurance policies.
 9. The Contractor shall provide Certificate of Liability equal to or exceeding \$1,000,000 for General Liability, which will cover performance of its services under this agreement. The contractor will carry complete, adequate workmen's compensation insurance covering all employees of the contractor. Current certificates of all insurance, showing the City as an additional insured, must be submitted to and maintained on file with the City.
 10. The Contractor will comply with all applicable federal, state, county and city ordinances and regulations in performing all services to be rendered by the Contractor under this Agreement. The City will comply with all applicable federal, state, county, and city ordinances and regulations in trail improvements.
 11. The contractor shall provide cell phone contact information to ensure communication during the installation of trail improvements.
 12. The contractor shall provide a written timeline of improvement installations.
 13. The proposal shall include a company narrative that includes, but not limited to:
 - The history of the company
 - The experience of the company
 - A descriptive narrative of the proposed ballfield improvements
 - A listing of completed ballfield improvements and municipalities the company has worked with in Texas in the past five years similar to the scope and size of this proposal and a list of these Texas cities of similar size and scope with contact information for reference purposes.
 - Photos, video or links to trail improvements projects that the company has completed during the last 5 years in Texas of similar size and scope.
 14. The City of Kyle reserves the right to increase, decrease and/or adjust the trail improvement needs based on adopted budget.

RFQ RESPONSE FORMAT:

The proposal shall be submitted that shows the final total costs to complete all scopes listed. It is required that you complete and return the RFQ Response Page and all supporting documents as listed in Scope to be considered.

TERMINATION FOR DEFAULT:

The City of Kyle reserves the right to enforce the performance of successful proposal in any manner prescribed by law or deemed to be in the best interest of the City in the event of breach or default of agreement. The City reserves the right to terminate the agreement immediately in the event the successful proposal fails to: 1) meet delivery schedules; 2) otherwise performs in accordance with these specifications. Breach of contract or default authorizes the City to, among other things, award to another proposal, purchase elsewhere and charge the full increase in cost and handling to defaulting successful proposal.

TERMS OF PAYMENT:

Any conditions other than payment in full 30 days after services provided shall be included in proposal. This includes deposits and payments made the night of the show must be written in the proposal.

LIABILITY INSURANCE:

The Contractor shall provide Certificate of Liability equal to or exceeding all State minimum required coverage and listing City of Kyle as additional insured. Proposal shall also provide evidence of worker's compensation insurance for all employees performing work on City Property.

RECORDS AND INSPECTIONS:

Contractor shall maintain full and accurate records with respect to all matters covered under this agreement for a period of three years after the expiration or termination of this agreement. City shall have the right to access and examine such records, without charge, during normal business hours. City shall further have the right to audit such records, to make transcripts therefrom, and to inspect all program data, documents, proceedings, and activities.

PERMITS AND APPROVALS:

Contractor shall obtain, at its sole cost and expense, all permits, and regulatory approvals needed in the performance of this agreement.

REFERENCES:

Required with Scope 13.

RFQ SUBMITTAL SCORING:

All complete proposals received will be reviewed by City Staff. The Staff's recommendation will go to City of Kyle Parks and Recreation Board for recommendation and then the Kyle City Council for final approval.
