# A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE NOVEMBER 3, 2020 GENERAL AND SPECIAL ELECTIONS OF THE CITY OF KYLE, TEXAS

**WHEREAS**, the City Council of the City of Kyle, Texas (City) held a General Election on November 3, 2020 for the purpose of electing three members to the Kyle City Council, each for three-year terms, specifically a Mayor, a City Council Place 2 and a City Council Place 4; and

WHEREAS, a special election was held in the City of Kyle to vote on Home Rule Charter Amendments; and

WHEREAS, the names of the candidates and the propositions were submitted, the election was held and conducted and the returns thereof were made, all as required by laws of the United States and the State of Texas, including particularly the Texas Election Code; together with all amendments and additions thereto; and

**WHEREAS**, it was found that the persons herein named received the following votes for said term of office on the Kyle City Council of the City of Kyle, Texas; and

**WHEREAS,** pursuant to the City Charter and Texas Election Code, the City Council of the City of Kyle, Texas, convened on this the 10<sup>th</sup> day of November, 2020, at 6:45 P.M. for the purpose of canvassing the vote in the general election held on November 3, 2020;

## NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KYLE, TEXAS, THAT:

#### Section One. Canvass of Vote - General Election.

(a) There came to be considered the returns of the general election held on the  $3^{rd}$  day of November, 2020, for the purpose of electing a Mayor and Council Members for Districts 2 and 4, and it appearing from said returns duly and legally made; that each of the candidates in said election received the following votes:

- (b) It is found, determined and declared by the City Council that said election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law; and that Yvonne Flores-Cale was duly elected to Council District 2; and that Ashlee Bradshaw was duly elected to Council District 4. Said above named parties are hereby declared duly elected to said offices, subject to the taking of the oath of office as provided by the laws of the State of Texas.
- (c) In accordance with the Constitution and the Texas Election Code, a Municipal Runoff Election is hereby called and ordered for Tuesday, December 8, 2020, at which election all qualified voters of the City may vote for the purpose of electing a mayor. The candidates for such runoff election shall be Travis Mitchell and Linda Tenorio, the two candidates in the general election who received the most votes.

#### **Section Two. Canvass of Vote – Special Election.**

(a) There came to be considered the returns of the special election held on the 3<sup>rd</sup> day of November, 2020, pursuant to Chapter 9, Tex. Loc. Gov't. Code, for the purpose of voting on the following propositions to amend the City Charter; and it appearing from the returns of said special election, duly and legally made, that each proposition received the following votes cast "FOR" the proposition submitted, and "AGAINST" the proposition submitted.

- (b) It is found, determined and declared by the City Council that said special election was duly called; that notice of said special election was given in accordance with law, returns of the election have been lawfully made by the proper officials, and that said election was held in accordance with law. Of each of the above-stated propositions, being submitted to only qualified, resident electors of the City for vote, Propositions C, D, E, F, and G resulted in more than a majority of the qualified votes voting at the election having voted to pass the proposition by the number of votes described in Section 2(a).
- (c) As approved and adopted by a majority of the qualified voters voting at such election the City of Kyle Home Rule Charter shall be amended as provided in the approved propositions and the ordinance calling the charter amendment election, and it is hereby declared that said amendments to the City of Kyle Home Rule Charter, as fully set out in the ordinance calling said charter amendment election, are hereby adopted.

**Section Three. Filing with the Secretary of State.** The City Manager, the City Secretary, and the City Attorney of the city are hereby directed to do and perform the tasks and responsibilities necessary and required to file a copy of the City Charter with the Secretary of the State of Texas.

**Section Four. Severability Clause**. If any part or parts of this resolution are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF KYLE, TEXAS CANVASSING THE RETURNS AND DECLARING THE RESULTS OF A BOND ELECTION HELD NOVEMBER 3, 2020, AND CONTAINING PROVISIONS NECESSARY AND INCIDENTAL THERETO

WHEREAS, on August 17, 2020, the City Council (the "Council") of Kyle, Texas (the "City") called a special election (the "Election") to be held on November 3, 2020, to authorize the approval by voters in the City of general obligation bonds for the purpose of planning, designing, constructing, improving and equipping a public safety facility and planning, designing constructing, improving, equipping and acquisition of real property for parks in the city; and

**WHEREAS,** the Council has reviewed and investigated all matters pertaining to this Election, including the calling, notices, election officers, holding and retunes thereof, and

**WHEREAS,** the Council hereby canvasses the returns of this Election, at which there was submitted to all resident, qualified voters of the City for their action thereupon, the following propositions:

#### City of Kyle Proposition A

"SHALL the City Council of the City of Kyle, Texas be authorized to issue general obligation bonds of said City in an amount not to exceed \$37,000,000 for the purpose of planning, designing, constructing, improving and equipping a public safety facility, specifically a new police station and emergency operations center in the City, and other costs related thereto; such bonds to mature serially or otherwise over a period not to exceed thirty (30) years from their date, to be issued and sold in one or more series at any price or prices and to bear interest at any rate or rates (fixed, floating, variable or otherwise and not exceed the maximum rate prescribed by law) as shall be determined within the discretion of the City Council at the time of issuance or sale of the bonds; and whether ad valorem taxes shall be levied upon all taxable property in the City sufficient to pay the annual interest and provide a sinking fund to pay the bonds at maturity?"

#### City of Kyle Proposition B

"SHALL the City Council of the City of Kyle, Texas be authorized to issue general obligation bonds of said City in an amount not to exceed \$10,000,000 for the planning, designing, constructing, improving and equipping of, and acquisition of real property for, parks in the city; such bonds to mature serially or otherwise over a period not to exceed thirty (30) years from their date, to be issued and sold in one or more series at any price or prices and to bear interest at any rate or rates (fixed, floating, variable or otherwise and not exceed the maximum rate prescribed by law) as shall be determined within the discretion of the City Council at the time of

issuance or sale of the bonds; and whether ad valorem taxes shall be levied upon all taxable property in the City sufficient to pay the annual interest and provide a sinking fund to pay the bonds at maturity?"

**WHEREAS**, the Council has diligently inquired into the poll lists and the official election returns which were duly and lawfully made available to the Council by the election officials holding and conducting such Election; and the official election returns showing separately the votes cast in the Election; and

WHEREAS, from these returns, the Council hereby finds that the following votes were cast in the Election by voters who were resident, qualified voters of the City as indicated on the official election results, which are attached as Exhibit "A" to this Ordinance, the totals of which are included below:

#### CITY OF KYLE PROPOSITION A

WHEREAS, the election was called and held in all respects under and in strict conformity with the Constitution and laws of the State of Texas and the United States of America;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KYLE, TEXAS THAT:

**Section 1. Preamble Incorporation.** The matters and facts recited in the preamble of this Ordinance are found to be true and correct.

Section 2. Special Election; Returns; Canvass. The Council officially finds, determines, and declares that the Election was duly and properly conducted, that proper legal notice of such Election was duly given in the English and Spanish languages (to the extent required by law), that proper election officers were duly appointed prior to the Election; that the Election was duly and legally held, that all resident, qualified voters of the City were permitted to vote at the Election, that the returns of the results of the Election have been made and delivered, and that the Council has duly canvasses such returns, all in accordance with the laws of the State of Texas and of the United States of America, and the Ordinance calling the Election.

#### Section 3. Special Election Results for the Propositions.

<u>Proposition A.</u> A majority of the resident, qualified voters of the City voting in such Election, have voted FOR Proposition A, the authorization and issuance of an amount not to exceed \$37,000,000 for the purpose of planning, designing, constructing, improving and equipping of a public safety facility, specifically a new police station and emergency operations center; and the levy of a tax in payment thereof.

**Proposition B.** A majority of the resident qualified voters of the City voting in such Election have voted FOR Proposition B, the authorization and issuance of an amount not to exceed \$10,000,000 for the planning, designing, constructing, improving and equipping of, and acquisition of real property for, parks in the city; and the levy of a tax in payment thereof.

The Council hereby finds and determines that the Election was duly called, that proper notice was given, that the Election was held in all aspects in conformity with the law, that the Propositions did carry at the Election, and that the City is accordingly authorized to issue and sell the bonds in accordance with the authority granted in the Proposition and with the law.

- <u>Section 4. Inconsistent Provisions</u>. All ordinances and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters ordered herein.
- <u>Section 5.</u> <u>Governing Law.</u> This Ordinance shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.
- <u>Section 6.</u> <u>Notice of Meeting.</u> It is hereby found that the meeting at which this Ordinance has been considered and adopted is open to the public as required by law, and that written notice of the time, place and subject matter of said meeting, and of the proposed adoption of this Ordinance was given as required by Chapter 551, Texas Government Code.
- <u>Section 7.</u> <u>Severability.</u> If any provision of this Ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and the Council hereby declares that this Ordinance would have been enacted without such provision.

<u>Section 8.</u> <u>Authorization to Execute</u>. The Mayor is authorized to execute, and the City Secretary is authorized to attest this Ordinance on behalf of the Council; and the Mayor is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

<u>Section 9. Effective Date.</u> This Ordinance will become effective immediately upon its passage and approval.

A RESOLUTION OF THE CITY OF KYLE, TEXAS, CALLING A RUNOFF ELECTION ON TUESDAY, DECEMBER 8, 2020, FOR THE PURPOSE OF ELECTING A MAYOR; PROVIDING FOR EARLY VOTING AND FOR NOTICE OF THE ELECTION; AND PROVIDING FOR OTHER MATTERS RELATING TO THE ELECTION AND SETTING AN EFFECTIVE DATE.

**WHEREAS**, under State law, if a candidate does not receive enough votes to be elected in an election requiring a majority vote, a runoff election is required for the candidates who receive the highest and second highest number of votes in the main election (Texas Election Code §§2.021, 2.023); and,

**WHEREAS**, under Section 5.02 of the Kyle City Charter, the mayor and council members shall be elected by majority vote; and

WHEREAS, not later than the fifth day after the date the final canvass of the main election is completed, the City Council must order the runoff election (Texas Election Code §2.024); and,

WHEREAS, the runoff election must be held not earlier than the 20th or later than the 45th day after the date the final canvass of the main election is completed (Texas Election Code §2.025); and,

**WHEREAS**, the Mayor has certified to the City Secretary that the candidates for Mayor, <u>Travis Mitchell</u> and <u>Linda Tenorio</u> be placed on the ballot for the runoff election (Texas Election Code §2.027); and

**WHEREAS**, the City has contracted with the Hays County Elections Administrator to conduct the City's runoff election, pursuant to *Chapter 31, Tex. Elec. Code* (the "Election Services Agreement);

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF KYLE, TEXAS:

**Section 1.** In accordance with the Constitution and general laws of the State of Texas, a Municipal Runoff Election is hereby called and ordered for Tuesday, December 8, 2020, at which election all qualified voters of the City may vote for the purpose of electing the following official of the City: Mayor.

**Section 2**. The candidates for such runoff election shall be <u>Travis Mitchell</u> and <u>Linda Tenorio</u>, the candidates in the general election receiving highest and second highest number of votes for Mayor.

**Section 3**. The polling places for the voting location in the City of Kyle for the Election Day voting shall be Kyle City Hall located at 100 W. Center Street Kyle, Texas 78640; Kyle Fire Station No. 2 located at 150 Bunton Creek Rd, Kyle, TX 78640; and Hays County Precinct 2 located at 5458 FM2770, Kyle, TX 78640 from 7:00 a.m. – 7:00 p.m.

**Section 4**. The Elections Administrator of Hays County, Texas, shall act as Contracting Officer (the "Contracting Officer") and shall appoint election judges, alternate judges, and clerks as described in the Election Services Agreement between Hays County and the City of Kyle, Texas.

**Section 5.** The Elections Administrator of Hays County, Texas, shall receive applications by mail for a ballot to be voted by mail, until the close of business on Friday, November 27, 2020 at 5:00 p.m. (received in office, not post marked). Requests for applications should be mailed to Jennifer Anderson, Hays County Elections Administrator, Hays County Elections Division, 712 South Stagecoach Trail #1012, San Marcos, TX 78666.

**Section 6.** The dates and times for early voting by personal appearance shall be as follows at the locations below:

#### **Kyle City Hall** 100 W. Center Street, Kyle, TX 78640

**Kyle Fire Station No. 2** 150 Bunton Creek Rd, Kyle, TX 78640

#### Hays County Precinct 2 5458 FM2770, Kyle, TX 78640

Thursday, Nov. 26, 2020 — (Polls Closed for Thanksgiving Holidays)
Friday, Nov. 27, 2020
Saturday, November 28, 2020 10:00 a.m. – 2:00 p.m.
Sunday, November 29, 2020 12:00 p.m. – 4:00 p.m.
Monday, November 30, 2020 — 8:00 a.m. to 5 p.m.
Thursday, December 3, 2020
Friday, December 4, 2020 6:00 a.m. – 6:00 p.m.

**Section 7**. Such election shall be held in accordance with the Texas Election Code and only resident qualified voters of the City shall be eligible to vote.

**Section 8.** Notice of the election shall be given as provided by law.

**Section 9.** Voting at the election, including early voting, shall be by use of the County electronic voting system that has been duly approved by the Secretary of State.

**Section 10.** The Hays County Elections Administrator and his/her employees and appointees, and the election judges, alternate judges and clerks properly appointed for the election, shall hold and conduct the election for the City pursuant to the Election Services Agreement. The runoff election shall be held and conducted by the Hays County Elections Administrators in compliance with the *Tex. Elec. Code* and, to the extent not inconsistent therewith, the *City Charter*. The Elections Administrator is hereby authorized and instructed to provide and furnish all necessary election supplies to conduct said election.

**Section 11.** The City Secretary is hereby authorized and instructed to aide the Hays County Elections Administrator in the acquisition and furnishing of all election supplies and materials necessary to conduct the runoff election. The City Secretary is further authorized to assist with the giving of

notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the *Texas Election Code*; provided that, pursuant to the Election Services Agreement, the Williamson County Elections Administrators shall have the duty and be responsible for organizing and conducting the election in compliance with the *Texas Election Code*; and for providing all services specified to be provided in the Election Services Agreement.

**Section 12.** That the returns of said election be made in accordance with the State Election Code and shall be canvassed by the City Council at a City Council Meeting.

**Section 13.** The Mayor is authorized to sign an Order of Election and a Notice of Runoff Municipal Election prescribed by the State of Texas on behalf of the City Council. The Notice of Runoff Municipal Election shall be published in accordance with the provisions of the Texas Election Code.

**Section 14.** Should any part, section, subsection, paragraph, sentence, clause or phrase contained in this resolution be held to be unconstitutional or of no force and effect, such holding shall not affect the validity of the remaining portion of this resolution, but in all respects said remaining portion shall be and remain in full force and effect.

**Section 15.** That this resolution shall be effective immediately upon adoption.
