



Re: Kyle's Downtown Revitalization/Area Plan

Dear Commissioners:

At the February Planning & Zoning Commission work session, the idea of consideration and discussion of the allowable uses in the CBD-1 and CBD-2 zoning categories was introduced. In the interim two weeks, staff and the commissioners both have reviewed the table of permitted uses in the city's zoning ordinance, §53-1230.

Attached to this memo are the initial reactions from select commissioners who provided early data on their research. Commissioner Harrel performed a cursory review of the allowable uses in the two districts and has made suggestions on some of the uses she feels need to be re-aligned. Chairperson Christie similarly submitted a higher-level narrative that considers those businesses that would draw a person to the downtown. Commissioner Voss considered not only uses that support residents, but those that attract tourists and other out-of-town persons. She further remarked that operating hours later into the evening, and even coordinating hours with events on The Square would help. Vice Chairperson Guerra made the connection between uses and a spatial analysis, or more clearly, a "sense of place" argument for what uses are allowed in each of the two districts, and where in the downtown those uses are presented on the city's current zoning map. Each of these early contributions are available as an attachment to this memo, and these analyses and the contributions from the remaining commissioners will be discussed at this work session.

This meeting will be an open session for discussion of the finding from that research. Additionally, it is expected that a fair amount of question and answers will be put forward both about the uses defined, and the parent ideals of downtown revitalization.

The intended deliverable would be a path to refinement of the table of permitted uses, if necessary, and a broader list of externalities that would be affected, or would need to be addressed, as a result of the proposed changes.



Consider & Possible Action to Direct the Planning & Zoning Commission to Revise the CBD 1 & CBD 2 zoning codes.

Comparing the current allowable uses for CBD-1 vs CBD-2, many of the highest foot traffic uses that would encourage pedestrian traffic/window shopping, are currently only allowed in CBD-2. Some of these uses include "Bookstore", "Pet shop", "Clothing" (except used clothing), "Hobby and game shop", and "Pharmacy". Many of the uses allowed in CBD-1 are less traffic heavy such as "Insurance agent", "Tailor", and "Tax return preparation".

If we keep this same general vision going forward we should expect that most foot traffic in our Downtown will stay within the CBD-2 zoned area.



I believe there is a disconnect between our current zoning map and the allowable uses for CBD-1 and CBD-2. Besides the Square, Center St only has 2 other blocks that are zones CBD-2, one East of the Square and one West. The majority of our CBD-2 goes North and South along the railroad tracks / Main St. CBD-1, except the area going towards the library, follows Center St starting at Nance St going West.

Besides the Square, where do we want our Downtown visitors to walk to? Center St is our primary road through our downtown yet well over half of Center St in downtown is CBD-1. If the map remains as it is now and if CBD-2 continues to be the only Central Business District that allows these heavier foot traffic uses we will have our heaviest pedestrian traffic from the

Square go North/South along Main St insead of East/West along our primary downtown road, Center St.

To correct this disconnect between our current zoning map and our current allowable uses for CBD-1 and CBD-2, I suggest one of two things happen. The first option would be to rezone Kyle's downtown. If CBD-2 included both the Square and the rest of Center St and CBD-1 were areas further off of the Square and Center St, then we would encourage most pedestrian traffic to be on the Square and on our primary downtown road. The other option besides rezoning would be to make the uses allowable in CBD-1 much more inclusive. If uses such as "Bookstore", "Hobby and game shop", and "Clothing stores" were allowed in CBD-1, we could keep the zoning map as is and have Center St encourage pedestrian traffic in both the CBD-1 and the CBD-2 sections of Center St.

Out of the two options I suggested, changing the zoning map or making CBD-1 more inclusive, I will focus on the latter going forward. I believe the zoning map change may be the best option but it might go beyond the scope of City Council's directive to P&Z.

I recommend most CBD-2 uses be allowed in CBD-1 except for a few key exclusions. Our current CBD-1 includes several residences and certain CBD-2 uses may not be a good fit near these residences. I suggest all CBD-2 uses be allowed in CBD-1 except for the following uses:

- 722410 (NAICS) Dance hall
- 5222 9800 Pawn shops
- 5221 1000 Banks
- 7132 9000 Bingo halls
- 5221 3000 Credit unions
- 7139 9003 Pool hall, billiards

The following uses are currently not allowed in CBD-1 or CBD-2 but I suggest they be added to both CBD-1 and CBD-2:

The following uses are currently not allowed in CBD-1 or CBD-2 but I suggest they be added to CBD-2 only:

The other change to the zoning code I would suggest is to update 53.418 to allow mutifamily in CBD-1. Multifamily is currently only allowed in CBD-2. A higher residential density in our Central Business Districts can play a major factor in increasing our downtown pedestrian traffic.

For me the downtown area needs to be shops, restaurants & cafes that would bring tourists & stay open during the evening & while events are taking place at the park.

While going through CBD 1 & 2 there are so many businesses to name that I feel don't belong downtown. Below is a small list:

- anything medical
- anything legal
- any "large" type businesses
 - mattress, furniture, computer non tourist type stores
- anything from the 80's
 - beeper services, vcr repair, video sales
