**RESOLUTION NO. 1329**

**A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE NOVEMBER 8, 2022 GENERAL ELECTION OF THE CITY OF KYLE, TEXAS**

**WHEREAS**, the City Council of the City of Kyle, Texas (City) held a General Election on November 8, 2022 for the purpose of electing two members to the Kyle City Council for a three-year term, specifically City Council Districts 1 and 3; and

**WHEREAS**, it was found that the persons herein named received the following votes for said term of office on the Kyle City Council of the City of Kyle, Texas; and

**WHEREAS**, the names of the candidates and the propositions were submitted, the election was held and conducted and the returns thereof were made, all as required by laws of the United States and the State of Texas, including particularly the Texas Election Code; together with all amendments and additions thereto; and

**WHEREAS**, pursuant to the City Charter and Texas Election Code, the City Council of the City of Kyle, Texas, convened on this the 15<sup>th</sup> day of November 2022, at 6:00 P.M. for the purpose of canvassing the vote in the general election held on November 8, 2022.

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KYLE, TEXAS, THAT:**

**Section One.** Canvass of Vote – General Election.

(a) There came to be considered the returns of the general election held on the 8<sup>th</sup> day of November, 2022, for the purpose of electing Council Members for Districts 1 and 3, and it appearing from said returns duly and legally made; that each of the candidates in said election received the following votes:

- (b) It is found, determined and declared by the City Council that said election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law; and that Miguel A. Zuniga was duly elected to Council District 3. Said above named party is hereby declared duly elected to said office, subject to the taking of the oath of office as provided by the laws of the State of Texas.
- (c) As no candidate for the office of City Council, District 1 received more than fifty percent of the vote as required by the City Charter, the City Council will order a run-off election for the office of City Council, District 1 by separate action in accordance with state law and the City Charter.

**Section Two. Severability Clause.** If any part or parts of this resolution are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extent this Resolution is considered severable.

**Section Three. Effective Date.** This Resolution will become effective immediately upon its passage by the Kyle City Council.

**RESOLUTION NO. \_\_\_\_\_**

**A RESOLUTION OF THE CITY OF KYLE, TEXAS, CALLING A RUNOFF ELECTION ON TUESDAY, DECEMBER 13, 2022, FOR THE PURPOSE OF ELECTING A COUNCIL MEMBER DISTRICT 1; PROVIDING FOR EARLY VOTING AND FOR NOTICE OF THE ELECTION; AND PROVIDING FOR OTHER MATTERS RELATING TO THE ELECTION AND SETTING AN EFFECTIVE DATE.**

**WHEREAS**, under State law, if a candidate does not receive enough votes to be elected in an election requiring a majority vote, a runoff election is required for the candidates who receive the highest and second highest number of votes in the main election (Texas Election Code §§2.021, 2.023); and,

**WHEREAS**, under Section 5.02 of the Kyle City Charter, the mayor and council members shall be elected by majority vote; and

**WHEREAS**, not later than the fifth day after the date the final canvass of the main election is completed, the City Council must order the runoff election (Texas Election Code §2.024); and,

**WHEREAS**, the runoff election must be held not earlier than the 20th or later than the 45th day after the date the final canvass of the main election is completed (Texas Election Code §2.025); and,

**WHEREAS**, the Mayor has certified to the City Secretary that the candidates for District 1, Amanda Stark and Bear Heiser be placed on the ballot for the runoff election (Texas Election Code §2.027); and

**WHEREAS**, the City has contracted with the Hays County Elections Administrator to conduct the City's runoff election, pursuant to *Chapter 31, Tex. Elec. Code* (the "Election Services Agreement).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KYLE, TEXAS:**

**Section 1.** In accordance with the Constitution and general laws of the State of Texas, a Municipal Runoff Election is hereby called and ordered for Tuesday, December 13, 2022, at which election all qualified voters of the City may vote for the purpose of electing the following official of the City: Council Member District 1.

**Section 2.** The candidates for such runoff election shall be Amanda Stark and Bear Heiser, the candidates in the general election receiving highest and second highest number of votes for Council Member District 1.

**Section 3.** The polling places for the voting location in the City of Kyle for the Election Day voting shall be Kyle City Hall located at 100 W. Center Street Kyle, Texas 78640 and Hays County Precinct 2 located at 5458 FM 2770, Kyle, TX 78640.



**Section 4.** The Elections Administrator of Hays County, Texas, shall act as Contracting Officer (the "Contracting Officer") and shall appoint election judges, alternate judges, and clerks as described in the Election Services Agreement between Hays County and the City of Kyle, Texas.

**Section 5.** The Elections Administrator of Hays County, Texas, shall receive applications by mail for a ballot to be voted by mail, until the close of business on Friday, December 2, 2022 at 5:00 p.m. (received in office, not post marked). Requests for applications should be mailed to Jennifer Doinoff, Hays County Elections Administrator, Hays County Elections Division, 712 South Stagecoach Trail #1012, San Marcos, TX 78666.

**Section 6.** The dates and times for early voting by personal appearance shall be as follows at the locations below:

**Section 7.** Such election is authorized to be held as a joint election in accordance with Chapter 271, Texas Election Code, this Resolution, and the Election Services Agreement with other political subdivisions holding an election on the same day in all or part of Hays County.

**Section 8.** Such election shall be held in accordance with the Texas Election Code and only resident qualified voters of the City shall be eligible to vote.

**Section 9.** Notice of the election shall be given as provided by law.

**Section 10.** Voting at the election, including early voting, shall be by use of the County electronic voting system that has been duly approved by the Secretary of State.

**Section 11.** The Hays County Elections Administrator and his/her employees and appointees, and the election judges, alternate judges and clerks properly appointed for the election, shall hold and conduct the election for the City pursuant to the Election Services Agreement. The runoff election shall be held and conducted by the Hays County Elections Administrators in compliance with the *Tex. Elec. Code* and, to the extent not inconsistent therewith, the *City Charter*. The Elections Administrator is hereby authorized and instructed to provide and furnish all necessary election supplies to conduct said election.

**Section 12.** The City Secretary is hereby authorized and instructed to aid the Hays County Elections Administrator in the acquisition and furnishing of all election supplies and materials necessary to

conduct the runoff election. The City Secretary is further authorized to assist with the giving of notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the *Texas Election Code*; provided that, pursuant to the Election Services Agreement, the Hays County Elections Administrator shall have the duty and be responsible for organizing and conducting the election in compliance with the *Texas Election Code*; and for providing all services specified to be provided in the Election Services Agreement.

**Section 13.** The returns of said election shall be made in accordance with the State Election Code and shall be canvassed by the City Council at a City Council Meeting.

**Section 14.** The mayor is authorized to sign an Order of Election and a Notice of Runoff Municipal Election prescribed by the State of Texas on behalf of the City Council. The Notice of Runoff Municipal Election shall be published in accordance with the provisions of the Texas Election Code.

**Section 15.** Should any part, section, subsection, paragraph, sentence, clause or phrase contained in this resolution be held to be unconstitutional or of no force and effect, such holding shall not affect the validity of the remaining portion of this resolution, but in all respects said remaining portion shall be and remain in full force and effect.

**Section 16.** That this resolution shall be effective immediately upon adoption.

**RESOLUTION NO. 1331**

**A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF A BOND ELECTION; AND OTHER MATTERS IN CONNECTION THEREWITH**

\* \* \* \* \*

WHEREAS, on August 22, 2022, the City Council (the *Council*) of the City of Kyle, Texas (the *City*) ordered an election to be held on November 8, 2022 for the purpose of determining whether the resident, qualified voters of the City would authorize the issuance of general obligation bonds by the City; and

WHEREAS, the Council has reviewed and investigated all matters pertaining to this election, including the resolving, notices, election officers, holding, and returns thereof; and

WHEREAS, the Council hereby canvasses the returns of this election, at which there was submitted to all resident, qualified voters of the City for their action thereupon, the following proposition:

**PROPOSITION A**

“Shall the City Council of the City of Kyle, Texas be authorized, in accordance with applicable law, to issue and sell one or more series of general obligation bonds of the City, in the aggregate principal amount of not more than \$294,000,000 with such series or issues of bonds, respectively, to mature serially or otherwise within not to exceed 40 years from their date and to be sold at such prices and bear interest at such rates (whether fixed, floating, variable, or otherwise, but in no case at a rate that exceeds the maximum rate per annum authorized by applicable law at the time of any such issuance), as shall all be determined within the discretion of the City Council, for the purpose of making permanent public improvements or for other public purposes, to wit: designing, demolishing, constructing, renovating, improving, reconstructing, restructuring and extending streets and thoroughfares and related land and right-of-way sidewalks, streetscapes, collectors, drainage, landscape, signage, upgrading technology and traffic signals, acquiring lands and rights-of-way necessary thereto or incidental therewith and installing related public art, with priority given to the following street projects:

- Bebee Road
- Bunton Creek Road
- Center Street
- Center Street (On-System)
- Kohler’s Overpass
- Kyle Parkway (Lehman Extension)
- Marketplace Avenue
- Old Stagecoach Road

- Windy Hills Road

and in providing for the above public improvements, the City Council shall have the option to utilize other funds available for such purposes and, after making due provision for the improvements listed above or determining that the public improvement project will not proceed for a reason heretofore described, the City Council may, in its discretion, use any excess funds for constructing, reconstructing, restructuring, and extending other streets and thoroughfares and related land and right-of-way sidewalks, streetscapes, collectors, drainage, landscape, signage, acquiring lands and rights-of-way necessary thereto or incidental therewith; and shall the City Council be authorized to levy and pledge, and cause to be assessed and collected, within the limitations prescribed by law, annual ad valorem taxes on all taxable property in the City sufficient to pay the annual interest and sinking fund to pay the bonds at maturity and to pay th costs of any credit agreements executed in connection with the bonds?"

and

WHEREAS, the Council has diligently inquired into the poll lists and the official election returns which were duly and lawfully made to the Council by the judges and clerks holding and conducting such election; the poll lists and the official election returns showing separately the votes cast in the election; and

WHEREAS, from these returns, this Council hereby finds that the following votes were cast in the election by voters who were resident, qualified voters of the City:

PROPOSITION A

“THE ISSUANCE OF BONDS IN THE AMOUNT OF \$294,000,000 FOR STREETS, BRIDGES, AND SIDEWALKS AND THE LEVYING OF A TAX IN PAYMENT THEREOF”

NOW, THEREFORE,

IT IS ACCORDINGLY FOUND, DECLARED, AND RESOLVED BY  
THE CITY COUNCIL OF  
THE CITY OF KYLE, TEXAS THAT:

SECTION 1: The Council officially finds, determines, and declares that the election was duly and properly ordered, that proper legal notice of such election was duly given in the English

language and the Spanish language, (to the extent required by law), that proper election officers were duly appointed prior to the election, that the election was duly and legally held, that all resident, qualified voters of the City were permitted to vote at the election, that due returns of the results of the election had been made and delivered, and that the Council has duly canvassed such returns, all in accordance with the laws of the State of Texas and of the United States of America, and the order calling the election.

SECTION 2: A MAJORITY of the resident, qualified voters of the City of Kyle, Texas voting in such election, having voted FOR/AGAINST the authorization and issuance of \$294,000,000 of bonds and the levy and pledge of the tax in payment thereof as provided in Proposition A, the Council hereby finds and determines that Proposition A [passed/failed] at the election, that the election was duly called, that proper notice was given, and that the election was held in all aspects in conformity with the law, and that the Council is hereby accordingly authorized to issue the bonds and to levy the tax in accordance with the authority granted in the Proposition and with law.

SECTION 3: The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Resolution for all purposes and are adopted as a part of the judgment and findings of the Council.

SECTION 4: All ordinances and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters resolved herein.

SECTION 5: This Resolution shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

SECTION 6: If any provision of this Resolution or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Resolution and the application of such provision to other persons and circumstances shall nevertheless be valid, and the Council hereby declares that this Resolution would have been enacted without such invalid provision.

SECTION 7: It is officially found, determined, and declared that the meeting at which this Resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Resolution, was given, all as required by Chapter 551, as amended, Texas Government Code.

SECTION 8: Pursuant to the provisions of Section 1201.028, as amended, Texas Government Code, this Resolution shall be effective immediately upon adoption, notwithstanding any provision in the City's Home Rule Charter to the contrary concerning a multiple reading requirement for the adoption of ordinances or resolutions.
