I. Call Meeting to Order

Vice Chairman Growt called the meeting to order at 6:11 p.m.

Present were Vice Chairman Growt, Commissioners Bowman, Fahy, McMurray, and Somma. A quorum was present. Chairman Rubsam and Commissioner Cohen were absent.

II. Citizen Comment Period with the Ethics Commission

Vice Chairman Growt opened citizen comments at 6:12 p.m.

Glen Hurlston addressed the Commission regarding his complaint against Chief Jeff Barnett. He mentioned contacting the Ethics Commission board members and read two emails aloud concerning members responses to his complaint against Chief Barnett. He said he would like for members who submitted a bias response to remove themselves from the committee. He requested an outside independent ethics review regarding the matter of his complaint against Chief Barnett.

With no one else wishing to speak, Vice Chairman Growt closed citizen comments at 6:16 p.m.

III. Approval of Minutes

Vice Chairman Growt brought forward the minutes for discussion. Mr. Akers stated that we had a training session on April 11, 2018 and probably should have brought the minutes sooner, but they ended up on this agenda. Chairman Rubsam arrived at 6:18 p.m.

2. Approval of the minutes of the April 11, 2018 Ethics Commission Meeting. ~ *Jennifer Holm, City Secretary*

Vice Chairman Growt moved to approve the April 11, 2018 Ethics meeting minutes with the knowledge that some members were not present at that meeting. Chairman Rubsam seconded the motion. All votes aye; motion carried 6-0.

3. Approval of the minutes of the August 12, 2020 Ethics Commission Meeting. ~ *Jennifer Holm, City Secretary*

Vice Chairman Growt moved to approve the August 12, 2020 Ethics Commission meeting minutes. Chairman Rubsam seconded the motion. All votes aye; motion carried 6-0.

City Secretary Jennifer Holm stated for the record, Commissioner Somma had a delay replay feedback and was muted. She stated if Commissioner Somma wanted to speak, she would need to unmute herself. The Commissioner's collectively acknowledged Ms. Holm's statement and continued with meeting items.

Consultation regarding pending ethics complaints by Glen Hurlston and procedures for their resolution, it being the duty of the attorney to the Commission under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas to consult with the Commission in closed session.

Chairman Rubsam announced the Ethics Commission would go into Executive Session to seek the advice of the Commission's attorney (Ethics Compliance Officer) pursuant to Section 551.071. Consultation regarding pending ethics complaints by Glen Hurlston and procedures for their resolution, it being the duty of the attorney to the Commission under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas to consult with the Commission in closed session.

The Ethics Commission convened into executive session at 6:24. Commissioner Cohen arrived at 6:25 p.m.

5. Take action on items discussed in Executive Session.

The Ethics Commission reconvened into open session at 6:39 p.m. Chairman Rubsam announced the meeting was back in session and would proceed with motions.

Due to feedback, Chairman Rubsam requested Vice Chairman Growt to call meeting back to order and proceed with any motions.

Vice Chairman Growt called the meeting back to open session at 6:42 p.m. Vice Chairman Growt announced no action was taken in Executive Session but he would like to make a motion for consideration by the commission.

Vice Chairman Growt moved to dismiss based on a two-year lack of jurisdiction, on the complaint against Mr. Earp. Chairman Rubsam seconded the motion. All votes aye; motion carried 7-0.

Vice Chairman Growt moved to dismiss based on, not a violation of items covered by the thics committee. Commissioner Bowman seconded the motion. All votes aye; motion carried 7-0.
